1. Name of the Society shall be : **You and I Foundation Hooghly**
2. The Registered Office shall be situated at : **26, Nearber Road, P.O.- Chinsurah WB:- 712101, Dist- Hooghly**
3. The Branch Office shall be situated at : **Nil**
4. The objects for which the society is established are:
  - a) To acquire, establish, start, aid, run, maintain or manage primary schools, libraries and charitable hospitals for the benefit of the public.
  - b) To arrange and organize lectures, debates, discussions, seminars & excursions for the diffusion of knowledge.
  - c) To publish or cause to be published useful literatures, papers, magazines, books etc for non-profit motive.
  - d) To study, cultivate and demonstrate the art of music and dancing. To promote & encourage advancement of Literacy, cultural, religious, scientific and technical education.
  - e) To help the needy students of all communities for the prosecution of studies.
  - f) To collect or preserve manuscript, painting, sculpture, works of all antiquities, natural history specimens, mechanical and scientific instruments and designs.
  - g) To help the aged, sick, helpless, handicapped and physically challenged and indigent persons.
  - h) To alleviate the sufferings of wild life, animals or other living creatures as may be deemed appropriate.
  - i) To engage and assist in such other philanthropic activities as may be deemed appropriate by the Governing body of the society.
  - j) To construct, maintain, improve, develop and alter any buildings, houses or necessary or convenient for the purpose of the society.
  - k) To do all such acts, deeds, matters and things as may be deemed incidental or conducive to the foregoing objects.
  - l) To undertake all kind of social action, development initiatives, reform etc. for uplifting conditions of people either in rural or in urban areas.
  - m) To collect or receive donations, grant-in-aid from indigenous Government both the union and state from abroad sources for expanding and extending supports to the activities of society.
  - n) To give and receive loans for any source for the cause of the people and the society if and when felt by the Governing body of the society.
  - o) To organize network program among the NGOs, and other like minded organizations for the development of people.
